## ORDERS OF JUSTICE COBBY MADE ON 1 MAY 2024

UPON APPLICATION of the plaintiffs by originating process dated 30 April 2024, AND UPON HEARING Mr J G Abberton for the plaintiffs, IT IS ORDERED THAT:

- 1. Pursuant to section 439A(6), the period in which the plaintiffs are required to convene a second meeting of creditors of each of the Companies is extended by a period of 90 days, ending on 31 July 2024.
- 2. The application of Part 5.3A of the Act to each of the Companies is varied such that section 439A(2) of the Act will provide that a meeting of the creditors of each of the Companies may be held at any time before the end of the 5th business day after the end of the convening period.
- 3. Pursuant to s 447A(1) of the Act, Part 5.3A of the Act is to operate such that the requirement on the plaintiffs to issue notices under s 75-15 and s 75-225(1) of the Insolvency Practice Rules (Corporations) 2016 (Cth) (IPR) be modified such that notice of the second meeting of creditors of each of the Companies will be validly given to any creditors, not less than five business days prior to the date of the proposed meeting, by:
  - (a) giving such notice electronically by email sent to the email address of any creditor (including any persons claiming to be creditors) of each of the Companies for whom or which the plaintiffs hold an email address;

- (b) sending such notice to the postal address or facsimile number, or as provided for by the Act or the IPR, to any creditors not being a creditor referred to in sub-order (a); and
- (c) causing such notice to be published in The Insolvency Notices website located at https://insolvencynotices.asic.gov.au.
- 4. Any person who can demonstrate a sufficient interest (including any creditor of the plaintiffs) have liberty to apply on two (2) business days' notice being given to the plaintiffs and the Court to modify or discharge any of these orders.
- 5. Notice of these orders be given to each of the creditors (including any persons claiming to be a creditor) of the Companies by 9am on Thursday, 2 May 2024 by:
  - (a) giving such notice electronically by email sent to the email address of any creditor of each of the Companies for whom or which the plaintiffs hold an email address;
  - (b) sending such notice to the postal address or facsimile number, or as provided for by the Act or the IPR, to any creditors not being a creditor referred to in sub-order (a); and
  - (c) causing such notice to be published in The Insolvency Notices website located at https://insolvencynotices.asic.gov.au.
- 6. The costs of this application be paid out of the assets of each of the Companies.
